ADVICE TO Trimsaran Community Councillors

The Community Council of Trimsaran requires you to declare Personal Interests on the Register of Officers Interests Form **within 28 days** of your Interest becoming apparent. Such Interests must be updated by you **within 28 days** of any change.

Interests of Close Family Members

In line with Audit Wales requirements, your declaration must include the interests of Close Family Members i.e. Partners and / or Children. This is in accordance with Financial Reporting Standard 102 (Related Party Disclosure). Further guidance is available at "Change to Declaration of Interest Form for Councilors, Co-opted Members & Senior Officers".

In essence a "Related Party Transaction" is a transaction which a Councilors, Co-opted Member, Officer or their close personal associate via another entity (Company, Trust etc.) has with the Council i.e. provision of services or contractual arrangements.
