Min 5652

Declaration from all councillors, that they were members of Trimsaran Village forum but that was on a personal and not prejudicial nature.

County Councillor declared a personal and prejudicial nature with item 7a on the agenda.

Min 5653

Minutes of the. January 27th.2025 meeting, was read and unanimously resolved to be a true record (copies of which had been previously circulated to members) be confirmed and signed as a true record of proceedings.

Min 5654 Matters Arising

- 1.Subgroup for the development of the old miner's hall have been asked to arrange a meeting for the 3 March with EGIN
2. Allt have been visited again in relation to reinstalling the footpath.
3. Meeting with Nia Griffin and First Bus management being arranged
4. Final SPF claim has been submitted and paid out.
5. Old miners hall sub application has been invited to the second stage
- 6.Meeting concerning Council tax, predicted increase of 9.75% has now been dropped to 8.9% money from Welsh government helped but the increase of 3.5% in National insurance increase charges did not help.
7. Awaiting quotations for the Old Miners Hall roof

9. Youth club staff costs are being covered by county until the end of the financial year.

Min 5656 County Councillors Report

3. Complaints of speed and noise from vehicles within the village need to be reported to GO-Safe Unitary Authorities on every occasion.

County councillor again declared an interest in the planning application to be discussed and left the room.

Min 5658 Planning

1. PL/08820 - Siting of 4no. Holiday-Let Lodges in Addition to 4no. Holiday-Let Lodges and Seasonal Camping Pitches (as granted planning permission under PL/06088) - Land adjoining Ffos Las Racecourse, Culla Road, Trimsaran, Kidwelly, SA17 4DE

Councillor expressed the following concerns on the application

1. Access to the location, due to road traffic collisions at that location.
2. Infrastructure – sewage
3. Biodiversity concerns
4. River assessment report required due to the proximity of the river to the location.
5. If the authority is mindful to pass the application, then a request to compensate for the trees that will be lost, and consideration be given to the planting to soften the aesthetics of the buildings

The clerk instructed to inform outcome to the planning authority.

2. The clerk with the Chairs permission introduced an appeal notice regarding Rhôs Farm, that had been lodged with the planning and environment decision Wales.

After some deliberation it was agreed to award four hundred pounds from the award.

County Councillor Kim broom confirmed that the matter had been an issue for several years and that promises to remove had not materialised and that an official complaint would be forthcoming.
